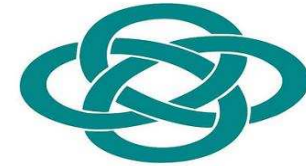

CHALLENGES THAT FPV FACES

- increasing access to sexual and reproductive health services for those who are most marginalized in Victorian communities;
- expanding the range of education and training resources available in the Victorian community;
- increasing awareness that sexual and reproductive health is a public health issue;
- promoting sexual and reproductive health care in a way that is sensitive to gender, sexual and cultural diversities;
- improving access to sexual and reproductive health education and training.

WHAT IS SEXUAL AND REPRODUCTIVE HEALTH?

Definition:

Sexual and reproductive health is a “state of complete physical, mental and social well-being and not merely the absence of disease or infirmity in all matters relating to the reproductive system and its functions and processes. Sexual and reproductive health is a broad concept that can encompass –

- **freedom from gender discrimination and violence;**
- **a safe and satisfying sex life without fear of infection, unwanted pregnancy or coercion;**
- **the capability to reproduce and the freedom to decide if, when and how often to do so;**
- **the ability to go safely through pregnancy and childbirth, and**
- **the ability to bear and raise healthy children.”**
