

# Towong Shire Council

**PEOPLE:** In the Australian Bureau of Statistics (ABS) 2011 census, there were 5,891 people in Towong. Of these, 50.5% were male and 49.5% were female. Aboriginal and Torres Strait Islander people made up 1.4% of the population.

**MEDIAN AGE:** The median age of people in Towong was 47 years. Children aged 0-14 years made up 18.0% of the population and people aged 65 years and over made up 21.7% of the population.

**COUNTRY OF BIRTH:** In Towong, 88.9% of people were born in Australia. The most common countries of birth were England 2.8%, New Zealand 0.7%, Germany 0.7%, the Netherlands 0.5% and Scotland 0.5%.

**LANGUAGE SPOKEN AT HOME:** In Towong, 96.1% of people only spoke English at home. Other languages spoken at home included German 0.5%, Italian 0.2%, French 0.1%, Spanish 0.1% and Polish 0.1%.

**EDUCATION:** In Towong, 26.4% of people were attending an educational institution. Of these, 31.0% were in primary school, 30.1% in secondary school and 13.8% in a tertiary or technical institution.

**RELIGIOUS AFFILIATION:** The most common responses for religion in Towong were Anglican 27.4%, no religion 22.9%, Catholic 20.8%, Uniting Church 9.1% and Presbyterian and Reformed 4.1%.

## Introduction

Data on female genital mutilation/cutting (FGM/C) has been gathered since the 1990s and informs preventative policies and programs aimed at abandonment of FGM/C and other harmful traditional practices (HTP). Data is gathered through surveys conducted in practising countries by the Demographic and Health Surveys (DHS) and the Multiple Indicator Cluster Surveys (MICS). The World Health Organization and the United Nations Children's Fund (UNICEF) draw on these figures to provide estimates of prevalence in the countries surveyed.

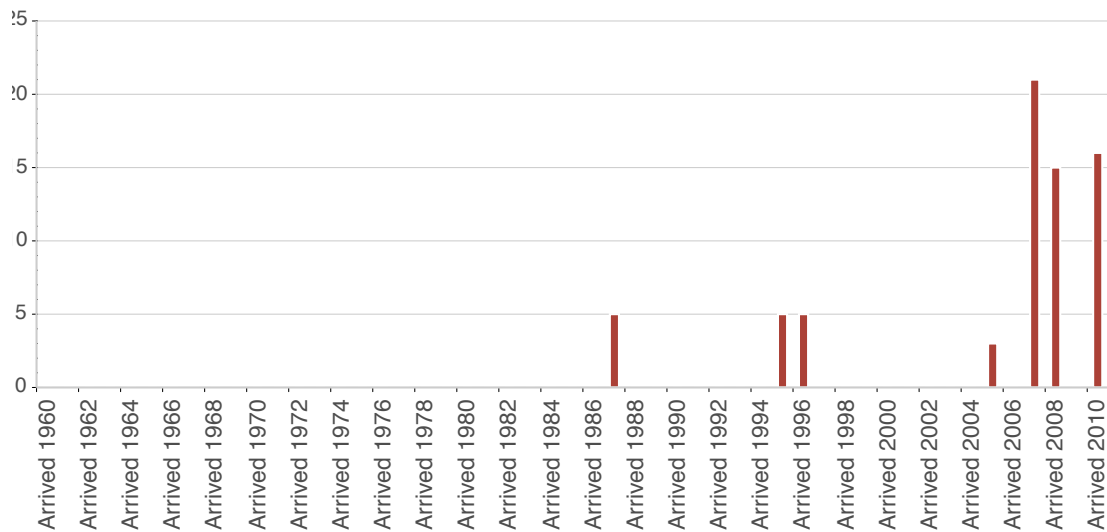
The DHS surveys include specific standardised questions about FGM/C in the countries where the practice is prevalent, including whether or not the woman responding and her daughters have been cut, the nature of the cutting and who performed it, and the respondent's attitudes towards the practice (UNICEF 2009, p. 14).

The MICS surveys have enquired about FGM/C since 2000, with the latest round in 2005-06 providing data for 13 countries. Both the DHS and MICS routinely collect data on the basis of region, urban or rural residence, age, household wealth and level of education, and increasingly on the basis of ethnicity (UNICEF 2009, p. 14).

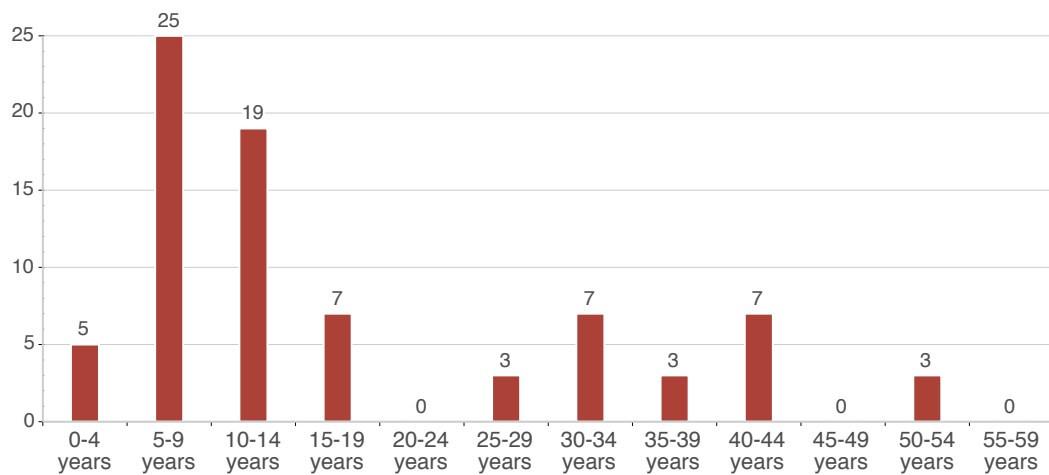

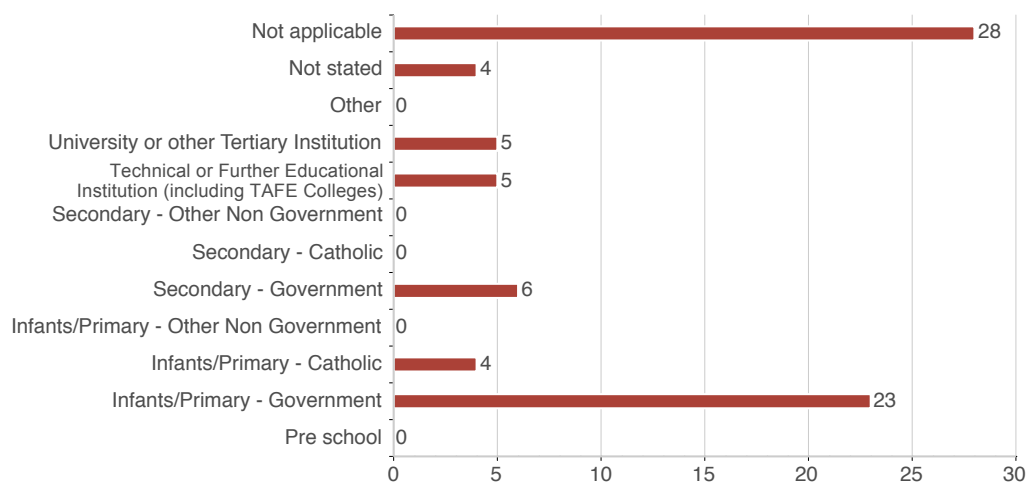

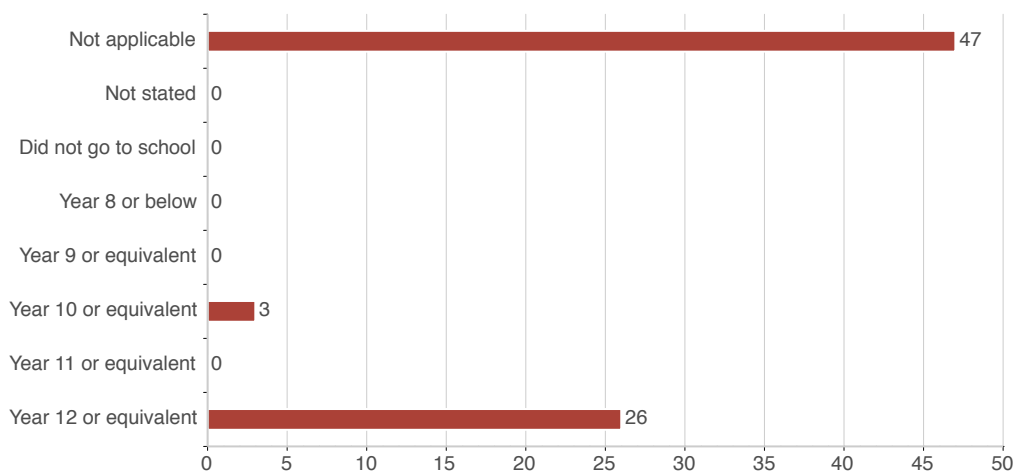

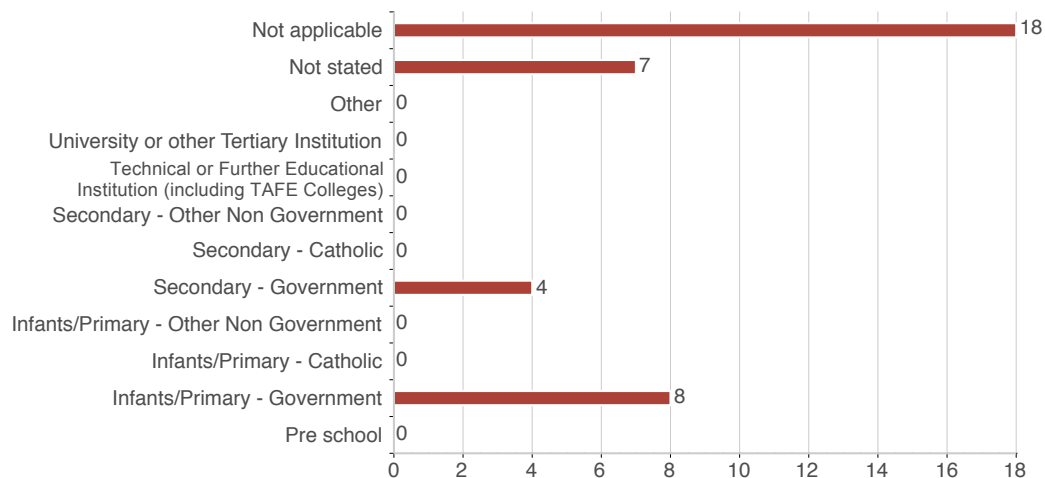

Year of age in 5 year age groups

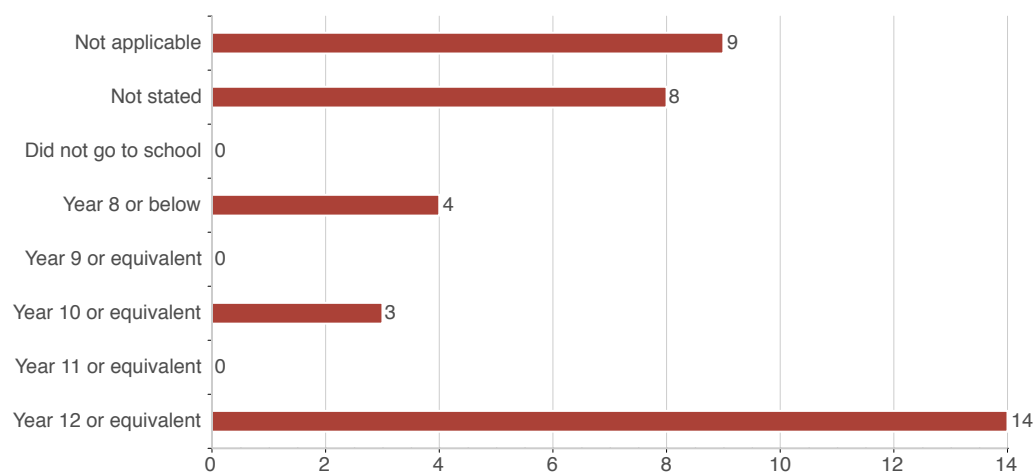

Year of age in 5 year age groups**

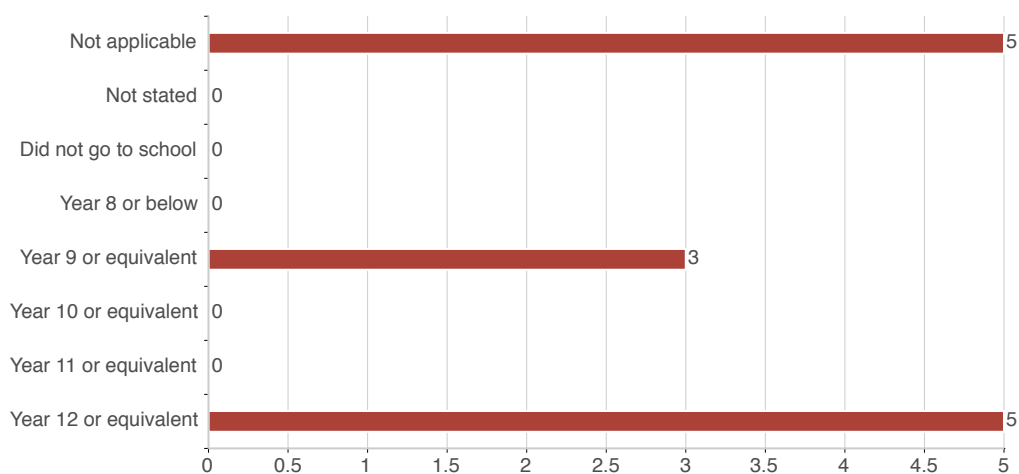

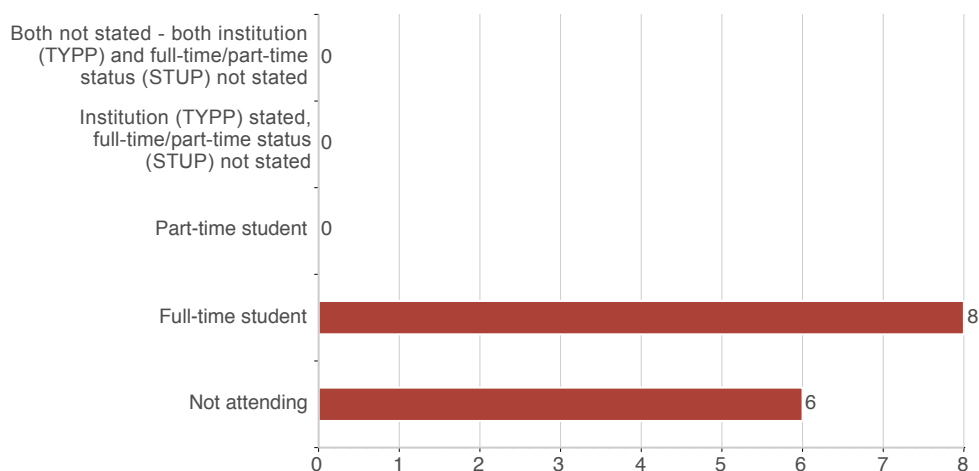

**Level of education: Highest school year completed**

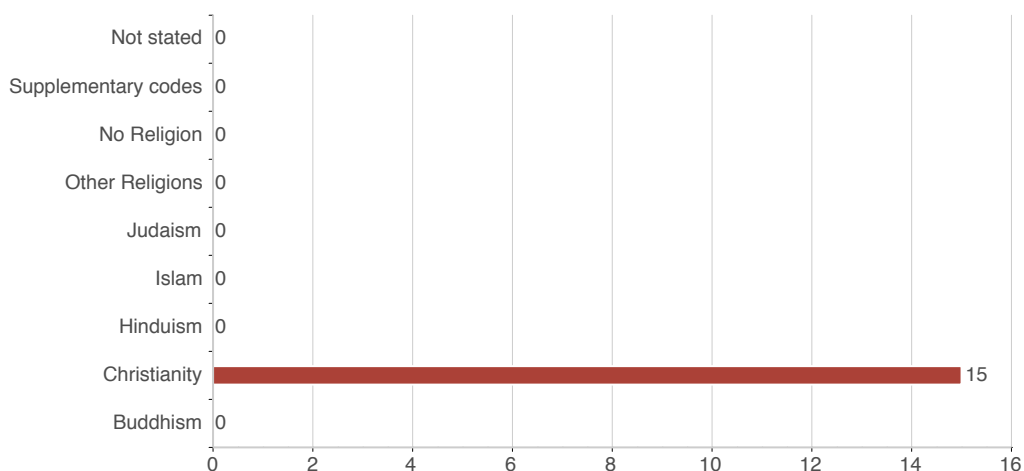

Year of age in 5 year age groups

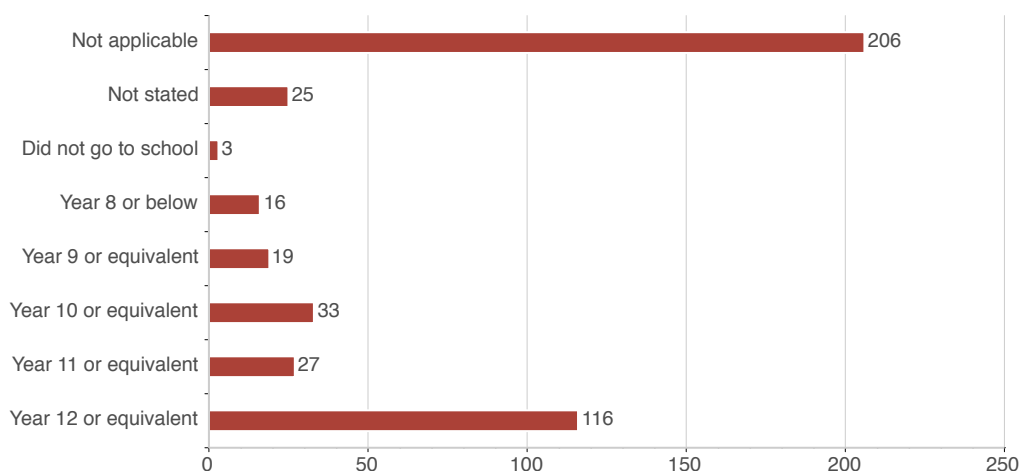

Year of age in 5 year age groups**

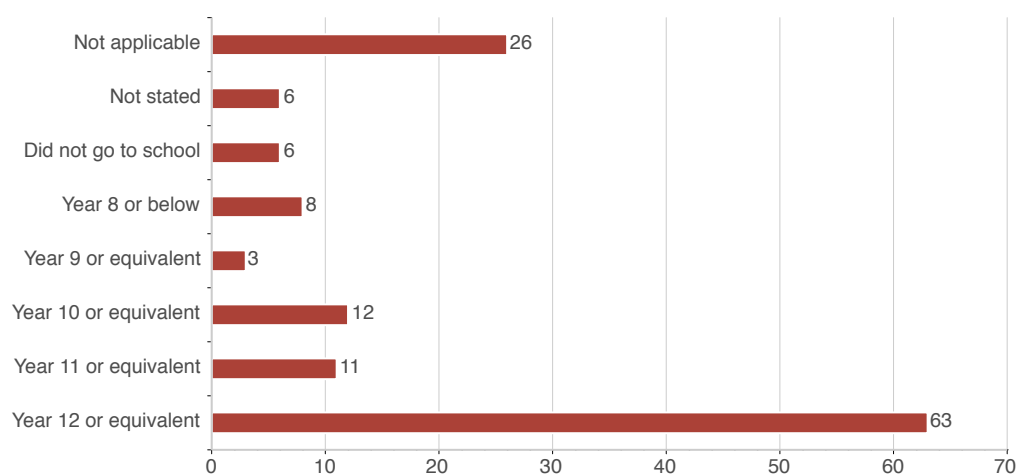

Year of age in 5 year age groups

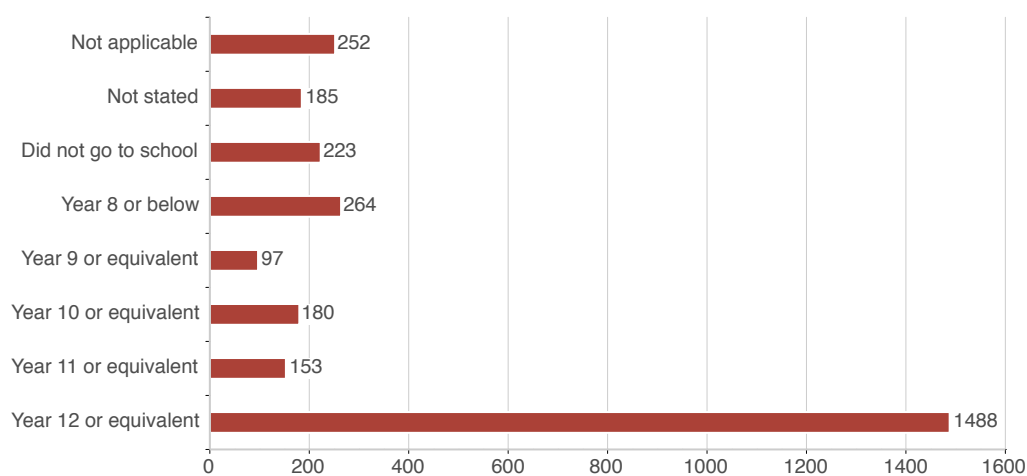

Year of age in 5 year age groups

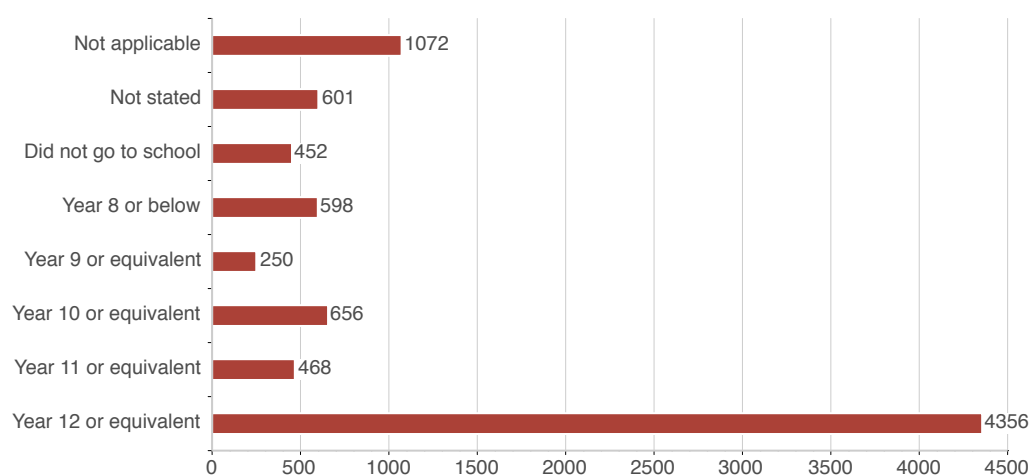

Year of age in 5 year age groups

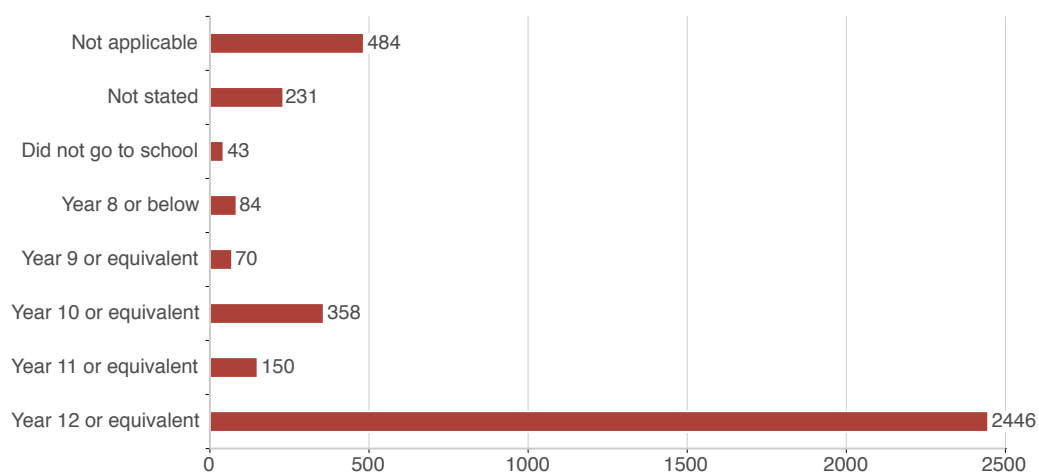

**Year of age in 5 year age groups**

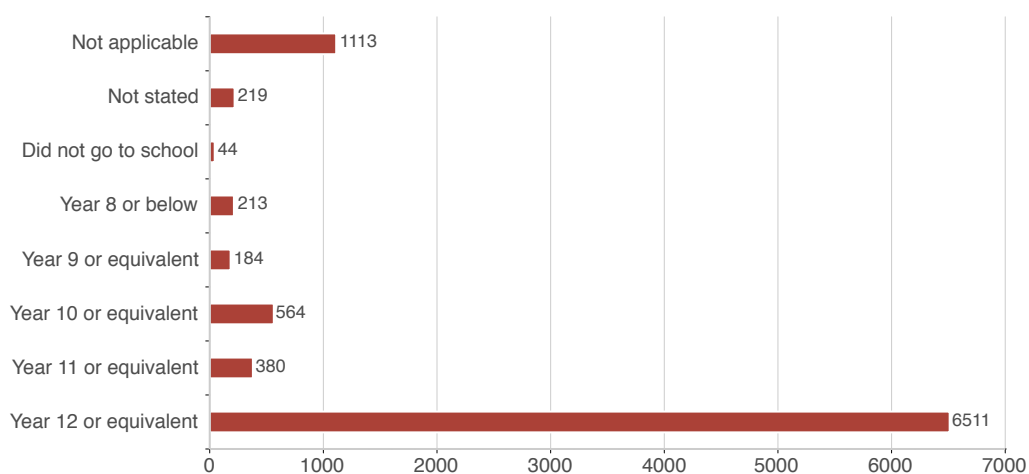

Year of age in 5 year age groups

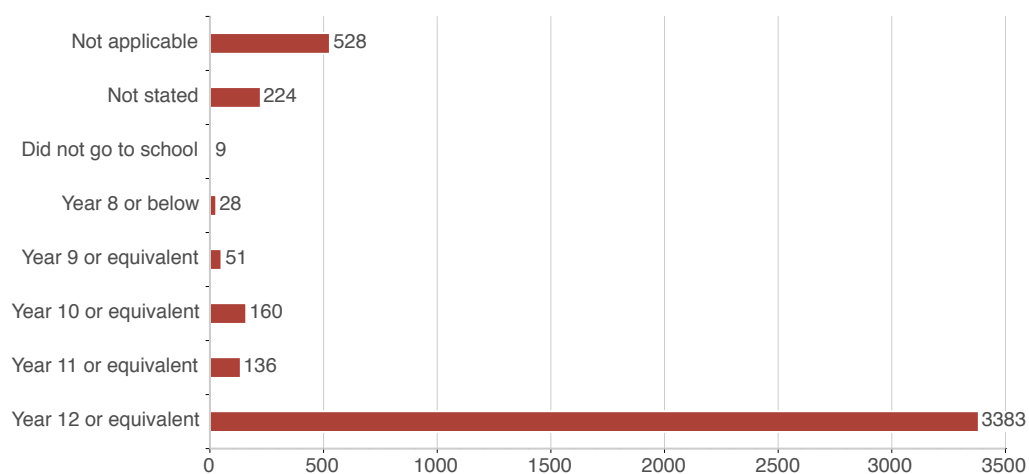

Year of age in 5 year age groups**

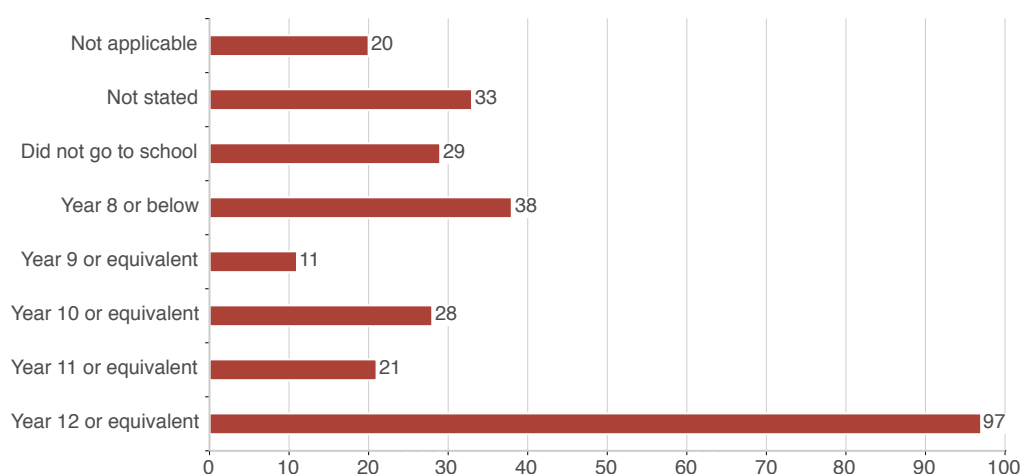

Year of age in 5 year age groups**



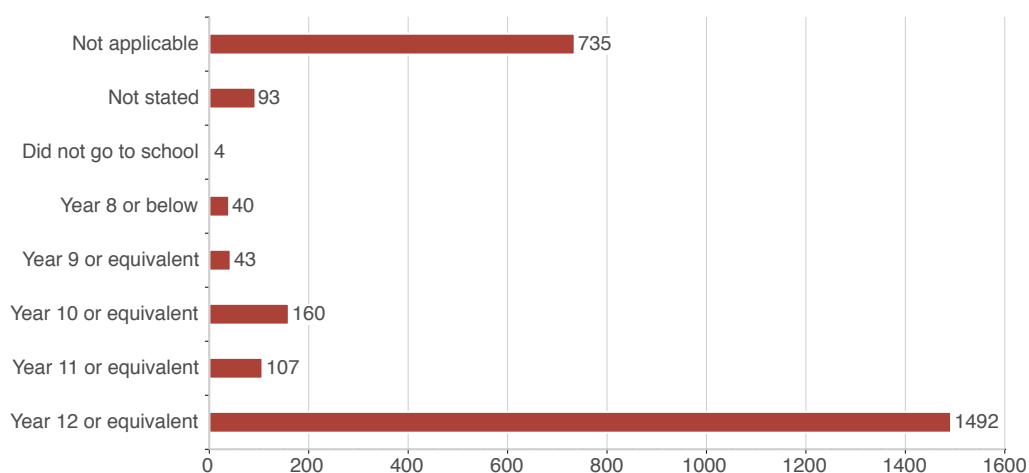

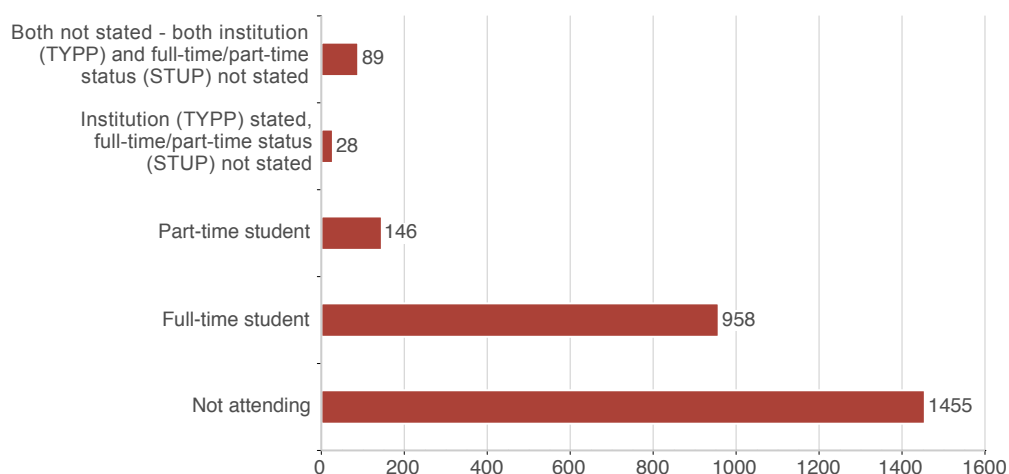


**Table 4: Australian residents born in Uganda**  
**Level of education: Highest school year completed**

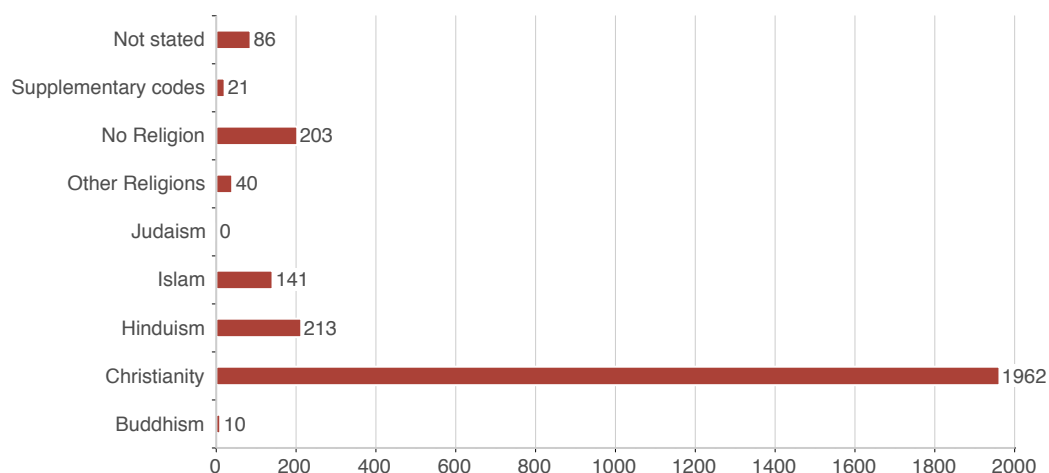

Student status: Full-time/Part-time**

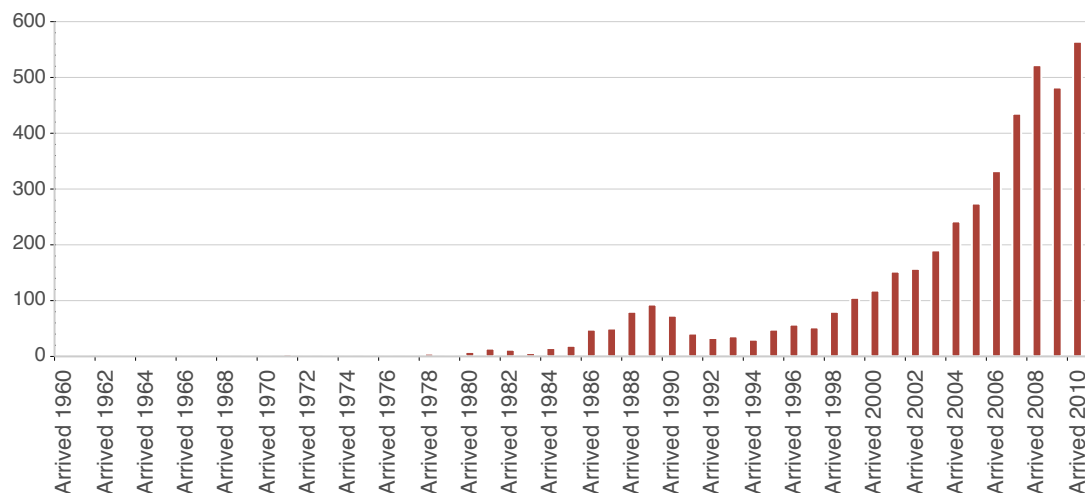


**Table 6: Australian residents born in Uganda  
Religious affiliation**

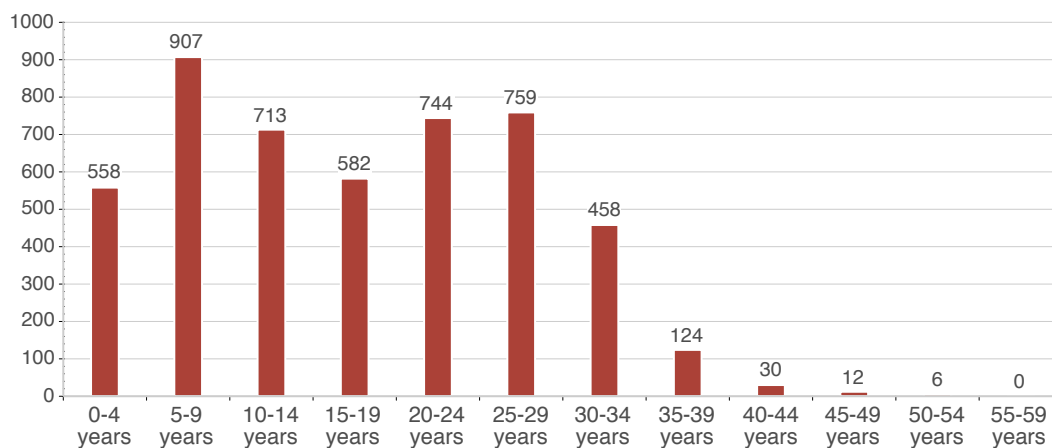

Year of arrival in Australia

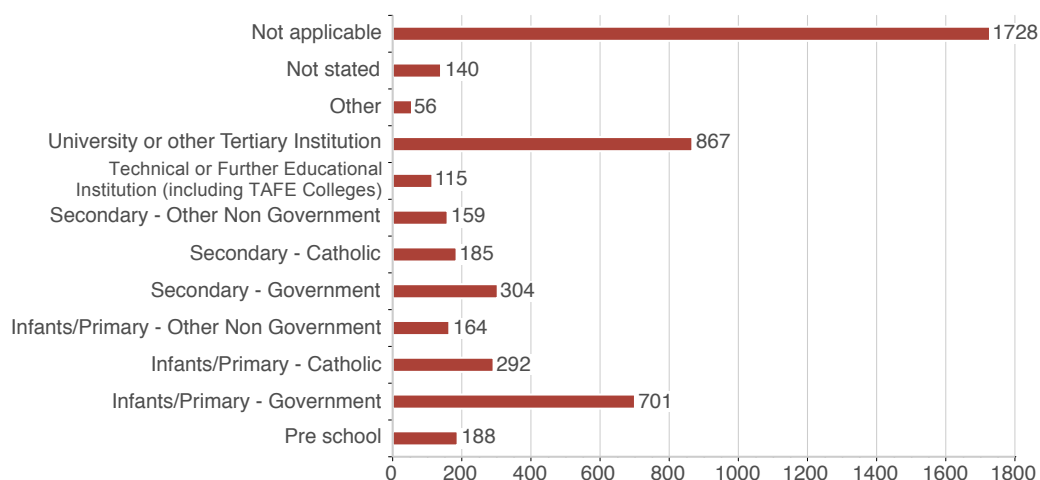


**Table 2: Australian residents born in United Arab Emirates**  
Year of age in 5 year age groups

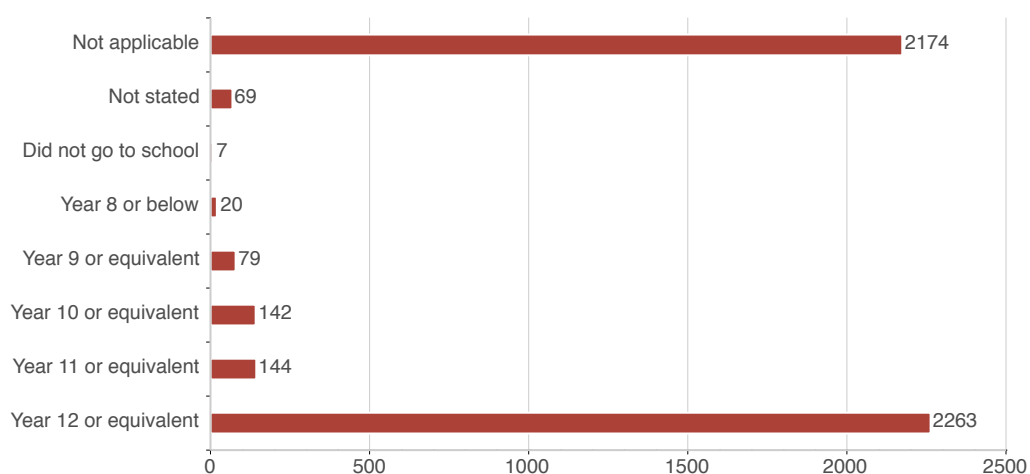

**Type of educational institution attending**

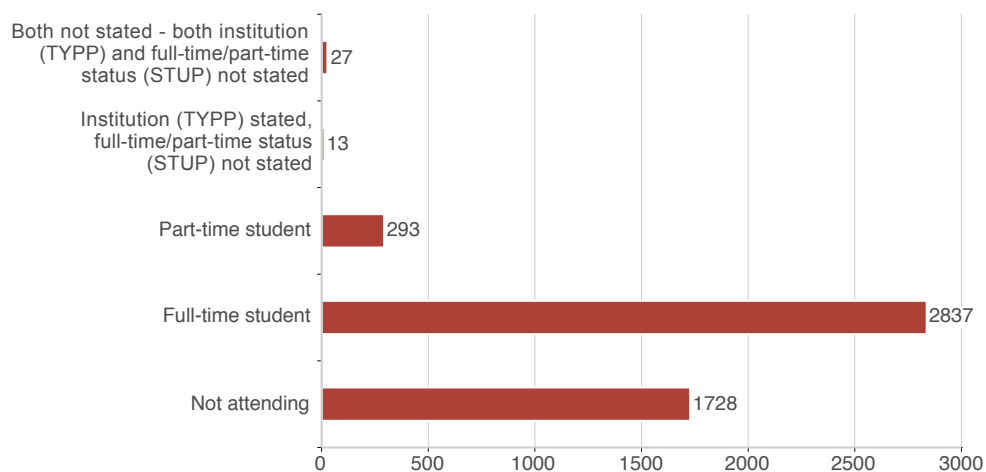


**Table 4: Australian residents born in United Arab Emirates**  
**Level of education: Highest school year completed**

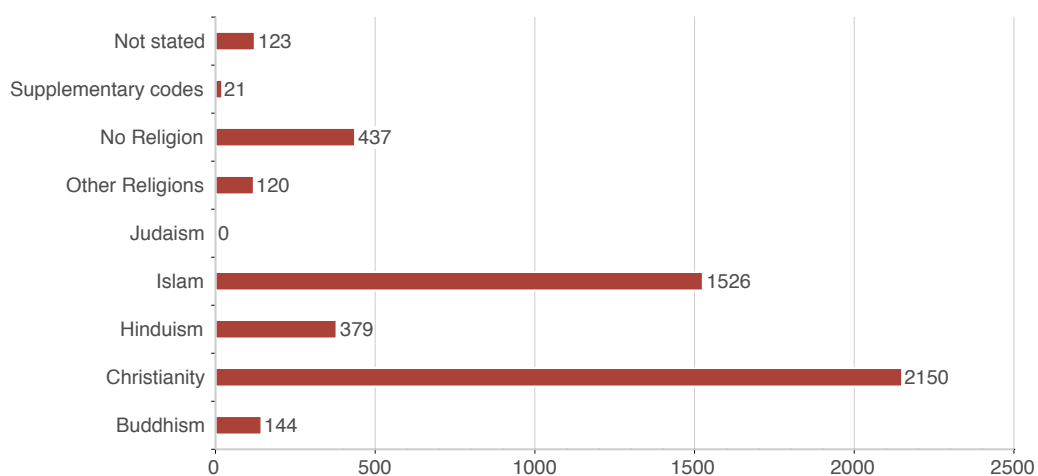

**Student status: Full-time/Part-time**

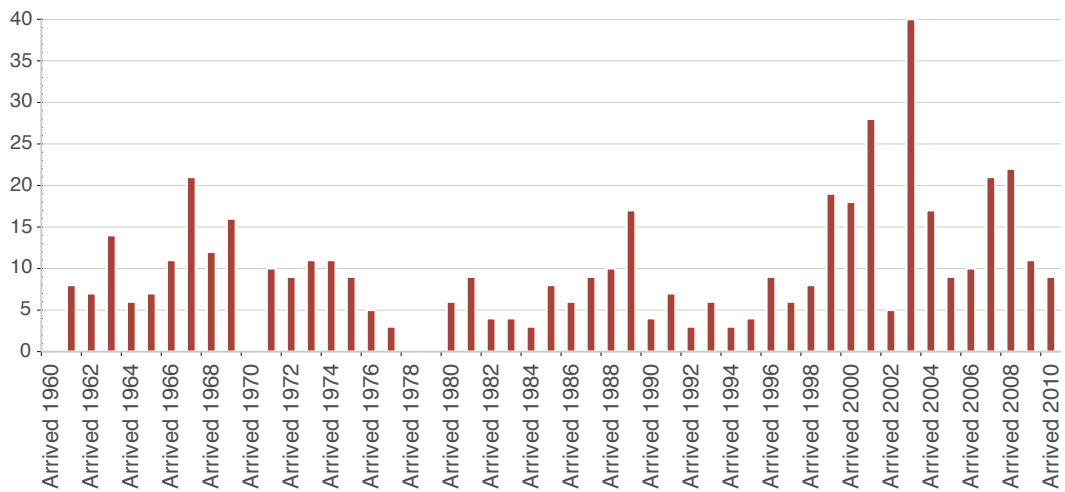


**Table 6: Australian residents born in United Arab Emirates**  
**Religious affiliation**

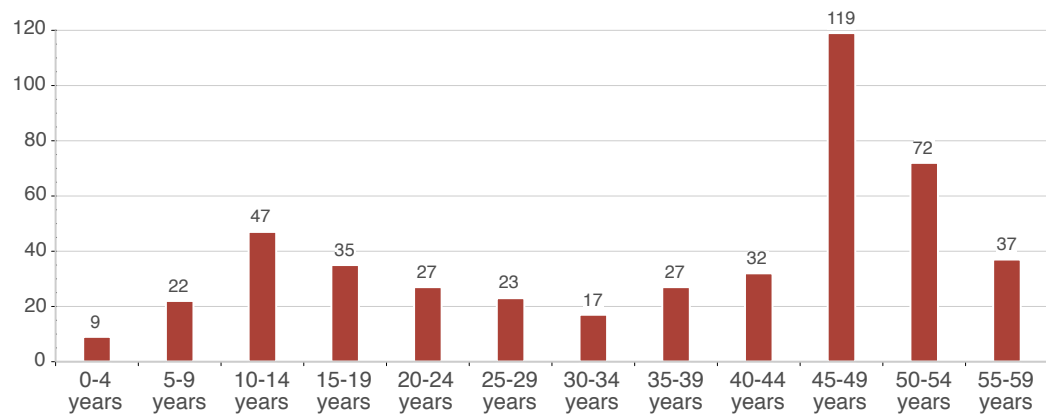

Year of arrival in Australia**

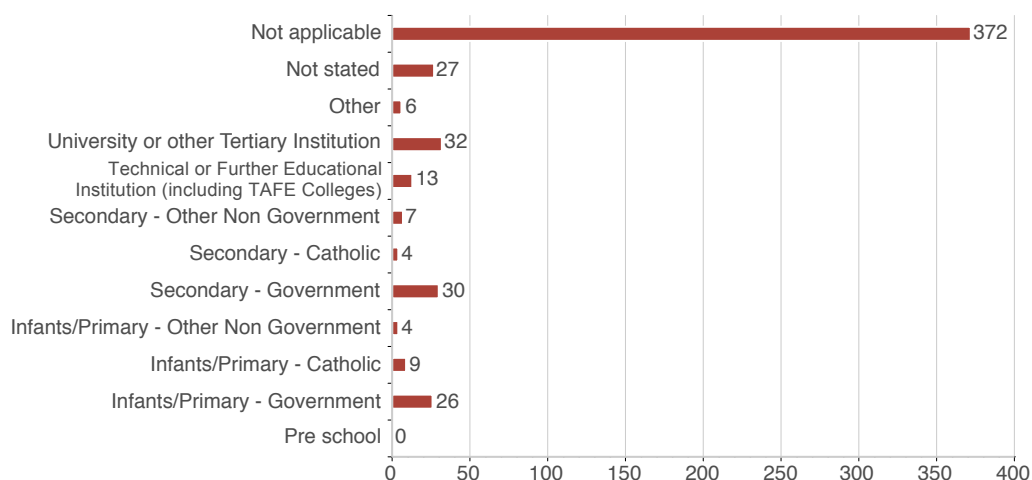


**Table 2: Australian residents born in Yemen  
Year of age in 5 year age groups**

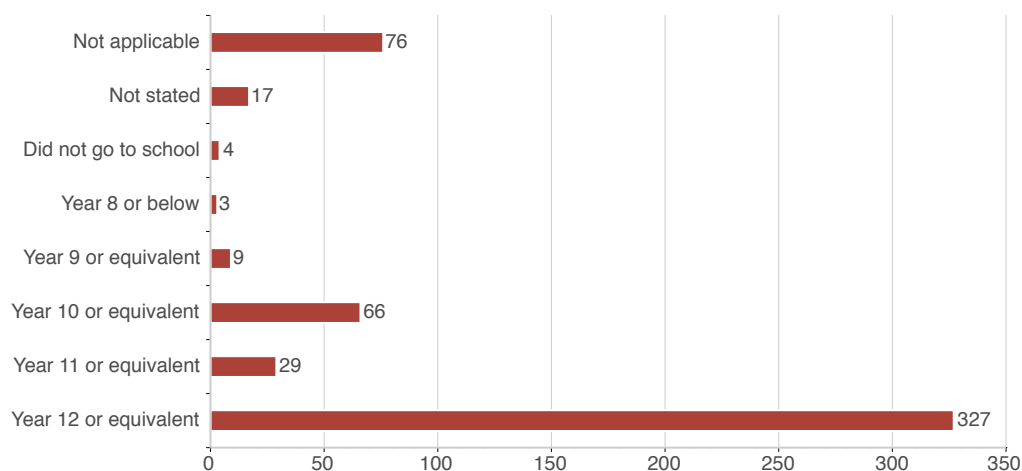

**Type of educational institution attending**

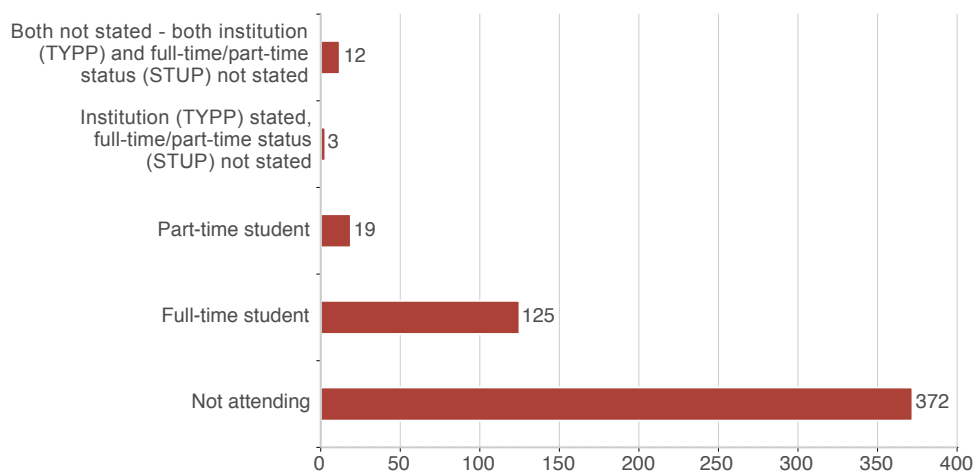


**Table 4: Australian residents born in Yemen**  
**Level of education: Highest school year completed**

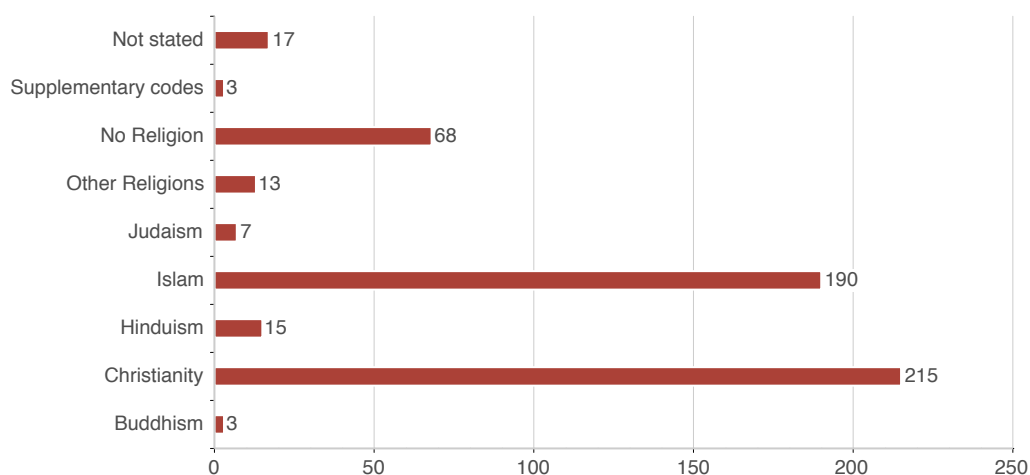
